**Thomas Croswell Re-elected as MAHP Board Chair**

This will be Croswell's second term leading the association's board of directors.

Croswell has served as president and CEO of Tufts Health Plan since January of 2016. As CEO of the region's only health plan that provides health insurance coverage across the life span regardless of age or circumstance, Croswell defines the company's strategic plan, ensuring Tufts Health Plan maintains its strong culture of quality, innovation and customer service. He joined Tufts Health Plan in 2007 as chief operating officer and was named president in 2013. He previously served as senior vice president of medical management and specialty businesses at CIGNA HealthCare. Prior to his career at CIGNA, he served in senior leadership roles at Prudential Insurance Company, including president of its western region and senior vice president of its individual insurance organization.

Croswell is a member of the board of directors of the Network for Excellence in Health Innovation, the New England Council, Massachusetts Business Roundtable, RI Quality Institute and America's Health Insurance Plans. He currently serves as a board member emeritus for the Alzheimer's Association MA/NH chapter, for which he also served as board chair. He is also a member of CEO Action for Diversity & Inclusion, a commitment to advance diversity and inclusion in the workplace. He is a past member of the board of directors of the National Committee on Quality Assurance and the Greater Boston Chamber of Commerce.

"MAHP is at the forefront of promoting high-quality, affordable care for all Massachusetts employers and consumers," said Croswell. "I am honored to continue to chair the MAHP board, as we work to find new and innovative ways to improve the health and wellness of all of the Commonwealth's residents."
