## **Thomas Croswell Re-elected as MAHP Board Chair** *President & CEO of Tufts Health Plan Elected to Third Term*

He joined Tufts Health Plan in 2007 as chief operating officer and was named president in 2013. He previously served as senior vice president of medical management and specialty businesses at CIGNA HealthCare. Prior to his career at CIGNA, he served in senior leadership roles at Prudential Insurance Company, including president of its western region and senior vice president of its individual insurance organization.

Croswell is a member of the New England Council, Massachusetts Business Roundtable, RI Quality Institute and America's Health Insurance Plans. He currently serves as a board member of the Alzheimer's Association MA/NH chapter, for which he also served as board chair. He is also a member of CEO Action for Diversity & Inclusion, a commitment to advance diversity and inclusion in the workplace. He is a past member of the board of directors of the National Committee on Quality Assurance and the Greater Boston Chamber of Commerce.

"MAHP continues to lead efforts to advance high-quality, affordable health care for all Massachusetts employers and consumers," said Croswell. "I am honored to continue to chair the MAHP board, working with dedicated health care leaders to ensure all Massachusetts residents have access to affordable, high quality health plans."
