MAHP Announces Senior Staff Promotions

Jason Aluia has been promoted to Vice President of Government & External Affairs. Jason leads MAHP's legislative efforts. He has been with the organization since 2010 and previously served as Deputy Chief of Staff and Legislative Director to former Speaker Sal DiMasi. Jason is the Chairman of the Ward 3 Democratic Committee in Boston and of the Board of Directors of the North End Waterfront Health Center. He attended Suffolk University.

Sarah Chiaramida has been promoted to Senior Vice President of Health Policy and General Counsel. Sarah will continue to lead the organization in priority areas including Medicaid, behavioral health and pharmacy, and serve as MAHP's General Counsel.
